PERSONAL INDEMNITY:

That the water in which spearfishing takes place has many hazards including but not limited to sharks, blue bottles, strong currents and dangerous waves. That boating in the sea off the KZN coast can be hazardous.

I accept the abovementioned risks and I voluntarily assume the risk inherent in taking part in such activities and I, together with my heirs, executors and administrators hereby release HUC, its officers, servants, agents and representatives, from any duty or care towards me, in connection with my participation in the mentioned activities, and from liability from all or any claims that could accrue to me or my heirs, executors and administrators arising out of my participation in any related activities irrespective of whether such claim or claims arose through the negligence of any person, or from any of the risks, dangers or hazards inherent in spearfishing and/or underwater hockey, or of any loss of, or damage to, any property from any cause whatsoever and I further indemnify and hold harmless associated persons against any claims howsoever the same may arise.

I have carefully read this release and indemnity and fully understand its contents. I am aware that this document affects my legal rights and liabilities and those of my heirs, next of kin and personal representative.
